NOTICE TO EXHIBITORS

The American Kennel Club (AKC) Rules and Regulations will govern this Trial and Exhibitors must make themselves familiar with the agreement of the AKC referred to on the reverse side of the entry form in this Premium List

No entry will be accepted which specifies any condition as to its acceptance. **Signature required, unsigned entries, and entries received without payment will not be accepted. Note: Entry Forms without the full AKC Agreement and Rules and signature on the reverse side will not be accepted.**

The Washington Poodle club assumes no responsibility for wrong or incomplete information given on the entry form by the owner or the owner's agent. ENTRANTS ALONE ARE RESPONSIBLE FOR THE COMPLETENESS AND ACCURACY OF ALL INFORMATION ON THEIR ENTRY FORMS.

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Club will add a \$25.00 collection fee to the amount of each returned check.

Refunds (minus an administration fee of \$5.00 per class) for bitches in season will be mailed to the Exhibitor after the conclusion of the trial if a veterinarian's certificate is presented to the Trial Secretary at least 30 minutes prior to the start of the trial.

Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made.

Entries will be acknowledged via email as they are received and processed. PLEASE VERIFY THE ACCURACY OF YOUR ENTRY INFORMATION as soon as you receive the processing email.

Confirmation and armband number will be sent via email after entries close. Those without an email address will be mailed by USPS to the address on the entry form.

Dogs must be ready for judging. Exhibitors alone are responsible for the presence of their dogs in the ring. Judges will not wait for any dog holding up a class.

LOSS OR DAMAGE – Both the Trial Committee and the show site owner will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Trials. The welfare of an Exhibitor's child is solely the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.

AWARDS will be awarded at the trial the day of the trial. No awards will be mailed.

Limited room for crates & chairs (bring your own and bring mats for underneath).

This is a one-ring trial. Training mirrors will be covered during the trial.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

UDX Entries: Please check the UDX box on the entry form. UDX entries will be entered in both Utility B and Open B. If either class fills by the closing date, then subsequent entries will be returned to the exhibitor in their entirety.

Transfers: Transfers will be permitted in accordance with the AKC Obedience Regulations, Chapter 1, Section 16. A completed Transfer Form must be presented to the Trial Secretary at least 30 minutes prior to the start of the trial. Blank forms will be available at the Secretary's table.

From the West: Take I-495 East to I-95 North to Exit 29A (Beltsville), onto Route 212 (Powder Mill Road). Cross Route 1 and, at the next traffic light, turn left onto Edmonston Road. Go two miles and turn left onto Distribution Drive (look for red L&W Supply Sign). Go past 84 Lumber on the right and turn right at the next driveway.

From the East: Take I-495 or 95 West to Exit 23 (Kenilworth Avenue/Route 201). Go North 4 miles, turn left at Distribution Drive (look for red L&W Supply sign). Go past 84 Lumber on the right and turn right at the next driveway.

From the North: Take I-95 South to Exit 29A (Calverton/Beltsville/Route 212). Go East on Route 212 (Powder Mill Road). Cross Route 1 and, at the next traffic light, turn left onto Edmonston Road. Go two miles and turn left onto Distribution Drive (look for red L&W Supply Sign). Go past 84 Lumber on the right and turn right at the next driveway.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the AKC Canine PartnersSM Program may be eligible to enter all-breed AKC Obedience & Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION.
